Preliminary Survey Summary

Note on Preliminary Summary: This summary report of the Fall 2020 Student Needs Survey is based upon an initial review of all responses. Further review will break survey responses down by different student populations.

Population Surveyed: All enrolled WNC students as of September 2020 (prison education program students excluded) (3055 total)

Response Rate: 31% (946/3055) Complete Response
37% (1125/3055) At Least Partial Response

Note on Population Surveyed: The COVID-19 pandemic has had a large impact on our student population and the communities we serve. Like many colleges, WNC has seen a decline in enrollment during the fall semester. It is likely that some of our most vulnerable students and community members have not enrolled due to current economic, health, and other concerns related to the ongoing pandemic. Their experiences and needs are therefore not reflected in these survey results.

Do WNC students have secure access to housing?

- **25% of respondents were housing insecure** during the last 12 months.
 - *Housing Insecure**: Inability or extreme difficulty paying rent, mortgage, and/or other bills related to housing; needing to move frequently; and/or living in an unsafe environment.
- **5% of respondents were homeless** during the past 12 months.
 - *Homeless**: Without a place to live; includes “couch surfing,” living in shelters, cars, outside, or other spaces not intended for habitation.

Do WNC students have secure access to food?

- **30% of respondents were food insecure** in the last 30 days.
 - *Food Insecure**: Limited or uncertain availability of nutritionally adequate and safe food, or the ability to acquire such foods.
- **23% of respondents were hungry** in the last 30 days.
 - *Hungry**: Reducing meal sizes, skipping meals, and/or not eating due to lack of access to food.
- **32% of respondents with children in their household reported their children were food insecure** in the last 30 days.
- **7% of respondents with children in their household reported their children were hungry** in the last 30 days.
- **39% of respondents would be interested in using a campus food pantry.**

How many WNC students are vulnerable to either housing insecurity OR food insecurity?

- **38% of respondents** were either food insecure during the past 30 days or housing insecure during the past 12 months.

How do WNC students pay for school and other expenses?

- **48% of respondents are employed.**
 - Of those employed, **43% work full-time.**
- **25% of respondents borrowed money from friends and family to pay bills** in the past 12 months.
- Top ways respondents pay for college and associated expenses:
 - **Employment** (non-work study): 40%
 - **Scholarships and Grants** (excluding Pell Grants): 36%
 - **Pell Grants**: 28%

Do WNC students have access to transportation to and from campus?

- **Yes.** 90% of all respondents report that access to transportation to and from campus is not a problem.

Do WNC students have internet access off campus?

- **Yes.** 98% of all respondents report having internet access off campus, and 97% of those with off-campus internet access report that it is of average or above average quality.

How has the COVID-19 pandemic affected students' employment and households?

- **43%** of all respondents report working as frontline or essential workers during the pandemic.
- **24%** of all respondents report losing their job, being furloughed, or having their work hours reduced as a result of the pandemic.
- **27%** of all respondents report that one or more members of their household are at higher risk or more vulnerable to COVID-19.
 - **2%** of all respondents report that one or more household members have tested positive for COVID-19.
- **10%** of all respondents report that they themselves are at a higher risk or more vulnerable to COVID-19.
 - **1%** of all respondents report that they have tested positive for COVID-19.

How has the COVID-19 pandemic affected the WNC student experience?

- **17%** of all respondents report having no quiet space to complete coursework at home.
- **11%** of all respondents report being unable to take required hands-on or in-person coursework (such as labs).
- **9%** of all respondents report reducing the number of courses they are taking due to pandemic-related changes at WNC (such reduced in-person class sizes and increased hybrid/online course offerings).
- **9%** of all respondents report reducing the number of courses they are taking due to pandemic-related financial difficulties.

Fall 2020 WNC Student Needs Survey Overview, Collection Timeline, and Response Rate Information

Survey Instrument Information

The Fall 2020 WNC Student Needs Survey is based on an adaptation of the national [Hope Center for College, Community, and Justice](#) #RealCollege survey that Walla Walla Community College conducted in 2018. In 2019, WNC's Office of Institutional Research and Effectiveness received feedback from colleagues at Walla Walla Community College about their experience to inform the survey's adaptation to WNC's student population. In Fall 2019, WNC successfully ran their version of the WNC Student Needs Survey. For Fall 2020, WNC again ran this survey, with the addition of COVID-19 impact questions and questions to identify the counties in which students live and the campus locations they attend. A question from 2019 breaking down a student's daily time usage was removed for the 2020 survey.

The following incentive prizes were offered to students via a prize drawing that students could enter after completing the survey: free 3-credit WNC class (2 available); Nintendo Switch; Acer Chromebook; Apple AirPods; Roku Streaming Media Player; and Amazon Echo Dot. The prize value of each class is approximately \$500, and the combined value of the additional prizes is approximately \$900. These prizes and amounts are similar to what was offered in 2019. Upon completion of the anonymous survey, student respondents were directed to a separate Google Form where they could input their contact information for the prize drawing. Duplicate prize drawing entries were removed, and winning students were chosen via random number generator.

Survey Collection, Timeline, and Response Rate Information

Population Surveyed: All enrolled WNC students as of September 2020 (prison education program students excluded) (3055 total)

Survey Collection Type: Students were emailed individual links to the survey via Survey Monkey, with weekly staggered reminders across a four-week period.
